GUIDELINES **FOR PUBLIC COMMENT:**

The public shall be allowed to speak only during the public comment period of the meeting or at such time as recognized by the presiding officer.

- Speakers must be visible.
- Speakers must give their name, address and organization, if any.
- Speakers must be recognized by the presiding officer.
- Speakers must limit their remarks to (5) five minutes on a given topic or extended if recognized by the presiding officer.
- Board members may, with the permission of the Mayor, interrupt a speaker during their remarks, but only for the purpose of clarification or information.
- All remarks shall be addressed to the Board as a body and not to any member thereof.
- Speakers shall observe the commonly accepted rules of courtesy, decorum, dignity and good taste.
- Interested parties or their representatives may address the Board by written communications in the event of creating a hardship to attend the meeting personally.

VILLAGE OF BROCKPORT NOTICE OF TENTATIVE BUDGET FILING & PUBLIC HEARING

Please take notice that on March 20th, the Mayor of the Village of Brockport filed with the Village Clerk the Tentative Budget of said Village for the fiscal year beginning June 1, 2012. It and the Treasurer's presentation of March 27th are available for review on the Village website at www.brockportny.org and at Village Hall during normal business hours.

The Mayor's tentative budget includes:

Projected General Fund revenues of \$4,747,091

Projected General Fund expenditures of \$4,747,091

Compensation proposed to be paid to each member of the Board as follows:

Mayor \$9,866/year & Trustees (4) at \$3,443/year – flat – no change from last year

Proposed tax rate of \$12.28/1,000 of assessed valuation – flat – no change from last year

Projected Water Fund revenues \$972,750

Projected Water Fund expenditures \$972,750

Proposed water rates – flat – no change from last year

Projected Sewer Fund revenues \$138,000

Projected Sewer Fund expenditures \$138,000

Proposed sewer rates – flat – no change from last year

The Trustees will recommend amendments to the Mayor's tentative budget and the Village Board will meet at 7:00pm on **Tuesday, April 10, 2012 at the Brockport Central School District's A.D. Oliver Middle School Auditorium, 40 Allen Street Brockport, NY 14420** for the purpose of holding a public hearing on the proposed budget of said Village for the fiscal year beginning June 1, 2012. All interested parties will be given the opportunity to be heard.
