Manager/Clerk - Erica L. Linden

- Customer Service training update On April 11th, from 10 am 12:30 pm all front facing staff had training in customer service with SUNY Brockport Public Administration Professor Phil LaPorta. Manager/Clerk Linden thanked the board for approving this beneficial training session.

DEPARTMENT REPORTS:

Treasurer - Daniel P. Hendricks / Clerk Treasurer Kari Pardun

March Financials – the board received the Treasurer's March report.

Building / Planning / Zoning / Code Enforcement - BI/CEO Chad H. Fabry

- Update on proposed municipal code hearings/process the code update is largely complete, which will be user
 friendly, for both village staff and residents. The village board may be voting on the updated municipal code in late
 May, depending on the feedback from the public and any concerns the board may need to address.
- Current dept. projects the next phase of the Property Maintenance Compliance project is postponed until the code re-write public hearings conclude during the month of April.

Police - Chief Mark T. Cuzzupoli

- Brief Report on Scholar's Day, April 12th Chief Cuzzupoli reported a few minor incidents occurred on April 11th. By the afternoon on April 12th, large crowds began to form on King St. A number of violations were occurred, and the decision was made to call for support from the Monroe County Sheriff's Office, University Police, and the New York State Police. After several hours of de-escalation, the officers dispersed the crowd. The Brockport Police Dept worked with the landlords to restore civility to King St. The Office of Student Conduct will receive incident reports for student violations. A meeting is scheduled with leadership at SUNY Brockport and Village Officials. With Eagle Day on April 22nd, Chief Cuzzupoli is collaborating with University Police Chief Vasile to be prepared.
- STOP DWI and Traffic Safety Board Awards Chief Cuzzupoli reported that the awards ceremony was earlier today. There were approximately 30 awards given and Brockport received four of them.
 - Officer Elliott Cave –Traffic Safety Board Certificate of Merit and Certificates of Appreciation Officer Cave handles many responsibilities in our small department which take a considerable amount of time to complete. His main responsibility is being our accreditation manager. Despite these additional responsibilities Officer Cave still has a passion for vehicle and traffic enforcement. While working the day shift, he was able to make 3 DWI arrests, one of which involved a school bus driver with students on the bus. Officer Cave further prevented traffic-related injuries/fatalities by issuing 438 traffic citations while issuing 228 traffic citation warnings in a little over 200 shifts worked. Additionally, he made 42 arrests for Aggravated Unlicensed Operation and 11 arrests for Operating a Motor Vehicle with a Suspended Registration.
 - Officer John Vadas STOP DWI Certificates of Appreciation Drug Recognition Expert Officer Vadas, Brockport Police Department received a Certification of Appreciation for his enforcement efforts in keeping the roadways of New York safe. Officer Vadas' proactive efforts removed 12 drivers off the roadway for Driving While Intoxicated over the course of the year. Furthermore, Officer Vadas, involved in his role as D.R.E., conducted six observations and for various agencies throughout Monroe County. One

of which resulted in the arrest and state imprisonment on second degree vehicular assault charges of a driver impaired by drugs whose actions took the life of a child and resulted in serious physical injury of Julia Resto in Ogden, NY. Officer Vadas manages administrative grant submissions for STOP DWI, High Visibility Enforcement Campaign, PTS, & Buckle Up NY. NYS Roadways are safer because of Officer Vadas' dedication to enforcement.

- Officer Evan Blodgett STOP DWI Certificate of Merit and Certificates of Appreciation Officer Blodgett received a Certificate of Appreciation in recognition of his commitment to DWI enforcement. Despite being assigned regular road patrol and many additional duties, Officer Blodgett made a concerted effort to focus on DWI enforcement and put together an excellent year. After switching to night shift in August until the end of 2022, Officer Blodgett made 247 traffic stops which resulted in many traffic citations and a total of 13 DWI arrests. Officer Blodgett made 9 DWI arrests in the month of December alone. During the course of these investigations, officers discovered violent offenders with warrants, firearms, and illegal substances which would have otherwise gone undiscovered if not for proactive policing. It is clear that Officer Blodgett is passionate about DWI enforcement and ensuring the safety of the people he serves.
- Brockport Police Department STOP DWI Department Award for the largest increase in DWI arrests for a Police Department classified as a small department.
- Resignation of PT Crossing Guard Charlene Kurzrock Chief Cuzzupoli received a letter of resignation from Charlene Kurzrock, effective 4-19-23. He expressed appreciation for her service to the community.

Public Works - Superintendent Dan Verace

- Chase parking lot update to date, DPW has installed 180 ft of curbing, installed a new catch basin, and completed 300 ft of sidewalk. Next, they will be milling the Chase parking lot and then paving soon after.
- Request for authorization to hire summer laborers, to work May October.
- → Mayor Blackman moved, Trustee LaPierre seconded, to approve hiring two seasonal laborers: Hunter Pierce and Steve Speed to work 40 hrs/wk, Monday-Friday, 7am-3:30pm.

- Local law to override the tax cap as established in General Municipal Law §3-c
 - The proposed budget will increase the tax levy by 9.8%
 - o 60% majority of the board required to override the NYS tax cap
- → Local Law No. 1 of the year 2023 Village of Brockport, County of Monroe

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Brockport to adopt a budget for the fiscal year commencing June1, 2023 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Brockport, County of Monroe, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2023 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment

shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

- Authorize the mayor to sign the Architectural / Engineering Contract with Fisher Associates to implement the TAP grant, specifically "The Smith Street Bridge, Pedestrian and Bicycle Improvements", known as PIN 4761.32. This contract has been carefully reviewed by Manager Linden and DPW Superintendent Verace. The project is not scheduled to begin until after the Main St Lift Bridge is reopened.
- → Trustee/Deputy Mayor Crane moved, Trustee LaPierre seconded, to authorize the mayor to sign the Architectural / Engineering Contract with Fisher Associates to implement the TAP grant, specifically "The Smith Street Bridge, Pedestrian and Bicycle Improvements", known as PIN 4761.32. Motion carried 5-0.
 - Authorize Village as lead agency in SEQR application in anticipation of the updated municipal code. Manager Linden noted that this is not an actual project, there will not be any effects to the environment. However, this is a requirement to have on file.
