## Weekly Media Release April 12, 2023 – April 19, 2023

### April 12, 2023

**Arrest:** Police arrested Jacob B. Sweet, 24 years old of Brockport, NY after a Violation of the Vehicle and Traffic Law was observed on Clinton Street. After an investigation, Sweet was charged with the Misdemeanor charges of Unlicensed Operator in the Second and Third Degree, Operating a Vehicle with a suspended registration as well as multiple other violations of the New York State Vehicle and Traffic Law. Sweet was released and is due in court at a later date.

### April 13, 2023

**Arrest:** Police arrested Christopher R. Brock, 21 years old of Brockport, NY after an investigation into a previous incident. After an investigation, Brock was charged with the Felony charges of Criminal Mischief in the Third Degree and Assault in the 2<sup>nd</sup> Degree of the New York State Penal Law. Brock was released and is due in court at a later date.

### April 14, 2023

**Investigation:** A Frazier Street resident reports damage done to a vehicle in the driveway during the overnight hours. The investigation is on-going.

**Arrest:** Police arrested Erick J. Moore, 37 years old of Parma, NY on a bench warrant after being turned over from Ogden Police Department. Moore was charged with the Misdemeanor charge of Criminal Possession of a Controlled Substance in the 7<sup>th</sup> Degree of the New York State Penal Law. Moore was released with an Appearance Ticket and turned over to the Gates Police Department for an outstanding warrant.

### April 16, 2023

**Investigation:** A Clark Street resident reports damage done to a home during the daytime hours by an unknown suspect. The investigation is on-going.

### April 18, 2023

**Arrest:** Police arrested Dennis J. Burke, 72 years old of Brockport, NY after a domestic incident. Burke was charged with the Misdemeanor charge of Criminal Trespass and the violation of Harassment in the Second Degree of the New York State Penal Law. Burke was released and is due in court at a later date.

From April 11 to April 17, 2023, the Brockport Police Department handled 441 calls for service, were dispatched to 6 Annoyance call, 3 motor vehicle accidents, 7 family troubles, 1 Burglary Reports, conducted 155 special attentions that include, but are not limited to, house checks, business checks, bike patrol, etc., conducted 54 traffic stops.
