## Weekly Media Release April 3, 2024 – April 10, 2024

#### **April 4, 2024**

**Investigation:** A Havenwood Drive resident reported damage done to the exterior of the home during the early morning hours. The investigation is ongoing.

## **April 5, 2024**

**Arrest:** Police arrested Kayla L. Crawford, 30 years old, of Brockport, NY after an investigation had taken place. After the investigation, Crawford was charged with 2 Counts of the Misdemeanor charge of Criminal Possession of a Controlled Substance in the Seventh Degree of the New York State Penal Law. Crawford was subsequently released with an appearance ticket and turned over to the Monroe County Sheriff's Office for an outstanding warrant.

**Arrest:** Police arrested Joshua R. Goodman, 43 years old, of Brockport, NY after an investigation had taken place. After the investigation, Goodman was charged with the Misdemeanor charge of Criminal Possession of a Controlled Substance in the Seventh Degree of the New York State Penal Law. Goodman was released and is due in court at a later date.

## **April 6, 2024**

**Investigation:** A victim reports damage sustained to a vehicle by an unknown suspect while driving in the area of Smith Street and Clinton Street. The investigation is ongoing.

**Arrest:** Police arrested Earl B. Benson, 35 years old, of Elba, NY after a vehicle traffic infraction was witnessed on College Street. After an investigation, Benson was charged with the Felony charges of Driving While Intoxicated, Aggravated Unlicensed Operation in the First Degree, the Misdemeanor charge of Operating a Vehicle without an Ignition Interlock Device as well as multiple other violations of the New York State Vehicle and Traffic Law. Benson was released and is due in court at a later date.

#### **April 7, 2024**

**Arrest:** Police arrested Trip D. Koroly, 32 years old, of Hamlin, NY on an outstanding Bench Warrant issued by the Village of Brockport Court. After the investigation, Koroly was charged with the Misdemeanor charge of Criminal Trespass in the Third Degree and the Felony charge of Criminal Mischief in the Third Degree of the New York State Penal Law. Koroly was released with an appearance ticket and subsequently turned over to the Ontario County Sheriff's Office for an outstanding warrant.
