February 28, 2024

Arrest: Police arrested Mair J. Morrison, 22 years old, of Chili, NY after a vehicle and traffic violation was observed at Utica Street and College Street. After an investigation, Morrison was charged with the Misdemeanor charges of Aggravated Unlicensed Operator in the Third Degree, Failure to Surrender License as well as multiple other violations of the New York State Vehicle and Traffic Law. Morrison was released and is due in court at a later date.

March 1, 2024

Arrest: Police arrested Bruce T. Clark, 46 years old, of Rochester, NY after the Village of Brockport Court issued an arrest warrant. After an investigation, Clark was charged with the Misdemeanor charges of Criminal Obstruction of Breathing, Criminal Mischief in the 4th Degree, Petit Larceny and Assault in the Third Degree of the New York State Penal Law. Brockport Village Court Judge Martin was notified of the arrest who declined arraignment and Clark was released with an appearance ticket returnable to the Brockport Village Court at a later date.

March 2, 2024

Arrest: Police arrested Shawn M. Whittier, 28 years old, of Albion, NY after a domestic incident was reported. After an investigation, Whittier was charged with the Misdemeanor charges of Criminal Mischief in the fourth degree and the violation of Harassment in the Second Degree of the New York State Penal. Whittier was released and is due in court at a later date.

Investigation: A Student Lane manager reports damage done to a building during the daytime hours. The investigation is on-going.

March 3, 2024

Arrest: Police arrested Dante D. Mancuso, 22 years old, of Batavia, NY after a vehicle and traffic violation was observed on Main Street. After an investigation, Mancuso was charged with the Misdemeanor charges of Driving While Intoxicated as well as multiple other violations of the New York State Vehicle and Traffic Law. Mancuso was released and is due in court at a later date.

Arrest: Police arrested Josheph R. White, 21 years old, of Brockport, NY after an investigation into a Brockport Village Code Violation. After an investigation, White was charged with the Misdemeanor charge of Obstructing Governmental Administration of the New York State Penal Law and the violation of Allowing Prohibited Noise of the Brockport Municipal Code. White was released and is due in court at a later date.
