## Weekly Media Release

**July 27, 2023 – August 2, 2023**

### July 30, 2023

**Arrest:** Police arrested Salvatore F. Pedone, 28 years old, of Parrish, NY after a fight. After an investigation, Pedone was charged with the Misdemeanor charge of Menacing in the Second Degree, two counts of the Violation of Harassment in the Second Degree and Trespassing of the New York State Penal Law. Pedone was released and is due in court at a later date.

### July 31, 2023

**Arrest:** Police arrested Colin J. Graham, 33 years old, of Brockport, NY after a Domestic Incident. After an investigation, Graham was charged with the Misdemeanor charge of Assault in the Third Degree and Endangering the Welfare of a Child of the New York State Penal Law. Graham was released and is due in court at a later date.

**Investigation:** An employee of a West Avenue business reports an unknown suspect broke into a vehicle in the parking lot by breaking the window and stealing multiples items inside said vehicle. The incident took place during business hours when the vehicle was left unattended. The investigation is on-going.

After an investigation, Karl was charged with the Felony charge of Criminal Possession of a Stolen Credit Card in the Fourth Degree and the Misdemeanor Charge of Criminal Possession of Stolen Property in the Fifth Degree of the New York State Penal Law. Haley was released and is due in court at a later date.
