OLD or NEW BUSINESS:

- Local law to override the tax cap as established in General Municipal Law §3-c
 - The proposed budget will increase the tax levy by 9.8%
 - 60% majority of the board required to override the NYS tax cap
- Resolution to approve the proposed budget for FY 2023-2024
 - Proposed budget includes a property tax levy of \$3,436,114
 - Proposed tax rate is \$11.13/\$1,000
- Authorize the mayor to sign the Architectural / Engineering Contract with Fisher Associates to implement the TAP grant, specifically “The Smith Street Bridge, Pedestrian and Bicycle Improvements”, known as PIN 4761.32.
- Authorize Village as lead agency in SEQR application in anticipation of the updated municipal code
